Notes from the CEO

2022 has been the year of huge achievements for YAL and there is much to celebrate. It has been a privilege to continue to lead this organisation as we again find our place in this changing world. With an active Board guiding the organisation we commenced the year with a strong strategic plan. This plan set clear priorities for growth, capacity, sustainability and engagement goals within YAL.

Over our long history YAL has continued to grow and learn through our journeys, metaphorical and metaphysical. This year saw us go on another journey to find a renewal of our brand. Understanding and appreciating the history was critical to this process and the recognition of our current place in the sector and how we are placed and recognised. With the guidance and support of consultant Ruth Perrin, the team went on a 9-month journey to understand and develop the renewed version of YAL, which we officially launch in April 2023. We thank Ruth for her work with the team during this journey. Our new logo captures the rising sun of the original logo and uses a franklin gothic font that was first used in 1905. The hues of purple in the "YAL" represent the evolution of our YAL which means so much to all of us.

No organisation would have the capacity to continue to grow and develop without the support of its sponsors, partners, and donors. Our flagship scholarship program YAL Connect has continued to grow, this year adding nine new recipients from three states and WA regional areas. With fifty recipients joining our program over the last 8 years, it is wonderful to play a small role in the journeys they have each gone on and know that we have helped play a role in them discovering their place in this crazy world. As we approach our tenth year in 2024, we are finding ways to follow their journeys and celebrate their achievements.

In April 2022 we advised our members that in order to better track the costings and outcomes of our programs we would make the change to a December year end. The impact of this decision would be that we would have an 18-month financial period and present these accounts to the members at our April 2023 annual general meeting. I would like to take this opportunity to thank CFO Amanda Brickwood and the team at Reliance Auditing Services for their tireless work in pulling this all together. 2023 will be a breeze after this exhausting exercise!

We as a Board are extremely proud of YAL's legacy and contribution to young people throughout its history. The organisation has evolved and developed to meet the needs of young people and assist them with overcoming their barriers, which may hinder their ability to be their best selves.

We hit some key milestones throughout the year. Some of the highlights from our activities this year include:

- Rebranding our scholarship program to YAL Connect.
- Appointing a Scholarship Coordinator.
- Granting 9 new scholarships up from 2 in 2021 due to the impact of COVID.
- Implementing a pilot of YAL Spirt

A Board trip to Cairns allowed the whole team to see the YAL Cairns site and enabled the Directors to meet with our Cairns based stakeholders, including and not limited to; Cairns Regional Council Mayor Bob Manning and his team, Department of Communities, Housing and Digital Economy regional representatives and Anglicare NQ CEO and QHome team. This was the first time a YAL Board has undertaken a trip to the Cairns facility and the opportunity provided the Directors a greater understanding of the relationships and facilitated further development of these critical partnerships.

This year we farewelled Directors Pieter Mulder, Rod Ross, Allan Tranter, and Pauline Vukojevic. We thank them all for their contribution to the organisation. Rod and Pieter are to be particularly recognised for their extensive work and commitment to the organisation during their long service.

With the departure of the retiring Directors, we welcomed two new Directors, Cate Sims and Jodie McQuillan, whose additions will provide further depth to the team.






YAL Connect

At the beginning of this year, I started my role as Scholarship Coordinator. The role's responsibility was to support the recipients within the YAL Connect program. I supported 15 young people from all over Australia. This support included but was not limited to monthly catchups, assistance with scholarship requirements, mental health support, assistance with unexpected barriers and educational / work obligations. Connect provided \$60,500 in financial support across 8 scholarship categories. This was the first year YAL employed somebody for the Scholarship Coordinator position, prior to this it was YAL's CEO Tammy-Rae Schaper who was coordinating the Connect program and supporting the recipients of the connect program in addition to YAL. With Tammy's exceptional guidance,my journey included the completion of my Bachelor of Youth Work, several learning curves, and the opportunity to empower the lives of 15 young people. The love and appreiation I have for my role grows each day.





Our purpose for 2022 was no different to our purpose in 2015 when YAL Connect was created, this purpose is to empower young people to become the best versions of themselves. To further track this intention, Tammy and I put together a list of 5 key outcomes we hope the young people within the program can achieve throughout their time with us. These include:

- 1. Increase in confidence and resilience persistence
- Increase in educational outcomes (this could be in educational engagement like school attendance improvement, taking up workshop, career development opportunities etc, not just grades)
- 3. Personal goals achieved

- 4. Increase connection with the YAL Family or greater community engagement
- 5. Increase of financial management/independence

Although these outcomes were developed in late 2022, they can still be easily matched with the journey of YAL Connect since it began in 2015. Moving forward, these outcomes will be used as a tool to measure the young person's progress and personal growth within the program.

2022 Presentation Event

This year we celebrated our scholarship recipients at the WA State Library for our annual presentation event. The event congratulated 9 recipients and gave the young people time to meet their sponsors and liaise with other recipients and YAL members. The presentation event was a formal occasion for YAL Connect's young people to be commended for their personal and educational journeys.

To allow the recipients to have a bit of fun and get to know each other a little better, YAL held our very first fun day. The fun day was planned to challenge, engage and make connections with the others in the Connect program. The event was held at Climb Zone in Bullsbrook. We started off the day at a local cafe in East Perth, then jumped into a maxi taxi and took off to the Climb Zone. The day was filled with team building, collaboration, endless laughs, and the forming of new relationships. The YAL fun day was a great addition to the Connect program and something we will continue to do for years to come.

Ash's Story

The journey of young people within our organisation is unique and exponential to each individual we have the privilege of supporting. In 2022 Ash officially joined the YAL Connect family, after being awarded the YAL Upper Secondary Scholarship. Being awarded the scholarship meant for year 11 and 12 Ash had the opportunity to move to a specialised art school in VIC. Ash has always had a passion for the arts and since being accepted into this school that passion has only grown stronger.

In the middle of 2022, Ash launched her very own art business, 'Bluesilverart'. Since launching her small business, Ash has already gained 512 Instagram followers, 38 Facebook followers, and has held several stalls at art festivals across Victoria. YAL was proudly one of Ash's first commercial customers, where she commissioned YAL stickers with our new logo. We have since used these stickers in numerous different ways throughout the organisation.

Bluesilverart now runs two group art classes for different ages of young people during the school holidays. In less than a year and at the young age of 17, Ash has already achieved so much.

Ash's life hasn't always been easy, and she has definitely faced hardships along the way.

But not once has she let these barriers stop her on her journey. She has always used resilience, persistence, and self-confidence to work towards her dreams. Ash has a bright future ahead of her, and we are so happy to be a part of her journey.

YAL Cairns

YAL Cairns has continued to be a vital component of YAL Ltd. YAL has been committed to being part of the Cairns and Far North Queensland community since we first occupied the site in 1948.

In 2020 we partnered with the Department of Communities, Housing and Digital Economy to utilise our site for the Anglicare NQ developed and operated QHome program. This unique program offers homeless and disadvantaged individuals support in developing skills and overcoming the difficulties they face due to their individual circumstances. YAL supports these activities by ensuring the site provides a safe, clean and comfortable environment for the clients to reside.

The sublease with the Department has been re-signed twice since the initial in 2020 and we look forward to this continued connection.

YAL and Anglicare have developed a strong partnership over the past four years which has allowed for the development of other opportunities to be explored together. During 2022 the Deputy CEO/CFO Amanda Brickwood led a new project of a food garden on site, YAL Patch. She worked closely with QHome Program Manager, Dearne Lang, to create a project that will allow the clients on site the access to skills development, health and wellbeing benefits, and social interaction through participation in building, tending, and interacting with the YAL Patch project. We are looking forward to formally opening this project in 2023.

November saw YAL Cairns welcome the YAL Board to Cairns as a group. This is the first time the whole board has been in the position to visit the Cairns facility. Unfortunately this excludes Michael Wainwright due to COVID. The trip however, was invaluable for the board to see our facility, meet the YAL Cairns team and the Cairns based stakeholders as well as get a feel for the region to better understand the challenges they face.

David Stanley continues to be an incredible leader of the Cairns team. Raelene and Deanna remain the heart of the amazing Cairns team both for contributions to operational activity and the human element of the work. While we said a sad goodbye to Howard and Colleen this year, we warmly welcomed Merv & Nancy.

In the nature of improving trajectories, YAL's CFO, Amanda Brickwood developed a food garden project for the clients residing at our Cairns facility, Anglicare NQ QHome program. Why a food garden you may ask? As well as being a source of mindfulness and connection to life and wellbeing, a food garden provides a multitude of positive opportunities for the individuals in the QHome program.

The benefits available through this project include:

- Education in planting, plant and soil care, natural pest management, harvesting, and sustainable practices.
- Skill development in teamwork, communication, social skills, responsibility, and resilience.
- Mental wellbeing and self-confidence through physical exercise, social engagement and inclusivity.

YAL is working with the Traditional Owners of the region for the inclusion of indigenous bush tucker foods and the sharing of knowledge of indigenous plants, care required, traditional uses and seasonal changes.

We are collaborating with and supported by Cairns Regional Council, Anglicare North Queensland, and the Department of Communities, Housing and Digital Economy. In addition, we are receiving support from local suppliers LJ's Plumbing & Gas, and Bunnings Cairns.


Stationery Drive

Over the years, YAL has formed several different relationships with other youth-based organisations, all of which provide a variety of benefits to young people. However, we noticed a gap in the limited funding provided to these organisations which restricts the different types of support that can be distributed. YAL Spirit is a developing program that aims to partner with other youth organisations to financially assist, as a 'one off' payment, for young Australians with a barrier to a specific item/service/experience in their journey.

YAL Spirit partnered with five youth organisations whose values and priorities aligned with us for the pilot.

- City of Swan Youth Work Team
- Stars Foundation
- Kalamunda & Districts Basketball Association
- Youth Focus
- Direction Psychology



The pilot program ran for 6 months. The funding requested was often a nominal amount, as little as \$66 for one referral and 10 of the referrals were for less than \$500, but the impact for the young person is significant. During the referring partners review meeting the partners voiced that by being able to refer their young people to this program with an easy application and quick turnaround, it helped them to build trust and belief that someone is on their side. This addition enhances the service to better support the young person.

Due to the success of the pilot the board endorsed the full roll out of the program for 2023.

Treasurers Report

A summary of the audited performance and position of Young Australia League Ltd (YAL) and the Young Australia League JJ "Boss" Simons Charitable Endowment Trust (Trust) have been provided herein. To view the complete set of audited financial statements please visit our website at www.yal.org.au or the ACNC website at www.acnc.gov.au

The significant surplus of 2021 enabled 18 months dedicated to growth and reinforcement of the organisation in line with the strategic plan. A great deal of work was completed behind the scenes and quite a journey in those 18 months, including:

- · Change in year end,
- · Updating our constitution,
- A previous breach of purpose remedied with the Department of the Prime Minister and Cabinet.
- Renewal of sublease with the Department of Communities, Housing and Digital Economy for our facility in Cairns,
- New projects underway collaborating with existing partners as well as with new partners on board.
- Transitioning our scholarship program accounting framework to sit within YAL where the program was already being administered, and
- A rebranding process to renew and support our purpose into the future.

100% of every dollar donated by our generous donors and sponsors goes directly to our scholarship recipients. We are working hard to manage the growth of our scholarship program, YAL Connect, as it continues to extend across the country. The team will continue working on funding sources for the administration of the program which remains entirely self-funded through operational activities. YAL is exteremly proud to currently have the capacity to cover all administration costs for our programs.

Throughout all the activities of the past 18 months the resulting gross operational surplus is a testament to the sound financial controls, skilled management team, strong governance, and as always true grit and determination from every person in the team working together for our purpose.

Turbulent financial markets and a change in accounting policy for depreciation pushed the net result towards a small deficit. Being predominantly an accounting function and unrealised loss, this is not a cause for concern and does not impede the direction of our journey.
